READ BEFORE INSTALLING HEATER

1. Correct installation of this heater is necessary for proper operation. Read and understand the installation manual enclosed before you attempt to install.
2. **DO NOT** install coolant heater in passenger compartment.
3. **DO NOT** install in enclosed areas where combustible fumes can be present. **DO NOT** install heaters in engine compartments of gasoline powered boats.
4. The heater exhaust is **HOT**. Keep a minimum of 2" clearance from any heat sensitive material.
5. Install heater exhaust so that papers, rags, etc., cannot come in contact with it.
6. Route heater exhaust so that exhaust fumes cannot enter the passenger compartment.
7. Heater must be turned off when vehicle or boat is being re-fueled.
8. Double check all fuel and exhaust connections for leaks after installation.

THE ESPAR LIMITED WARRANTY

Espar Products, Inc. ("Espar") warrants its products to be free from defects in materials and workmanship when operated under normal conditions, subject to the exclusions, limitations and conditions set forth below. Espar's sole obligations under this warranty are as follows:

Espar will, at its option, repair or replace all heater parts, which prove to be defective in materials or workmanship during the heater warranty period. All heaters have a one (1) year, one thousand (1000) operating hours (which ever comes first) warranty period commencing on the date of installation or date of sale with the exception of the *AIRTRONIC 2 / 4*, *B/D1/3LC compact*, *HYDRONIC 4 / 5* which have a two (2) year, two thousand (2000) operating hours (which ever comes first) warranty period. The warranty period for Original Equipment Manufacturer (OEM) installations commences on the date of sale or the date of licensing for public use -- whichever is earlier. Labour performed by authorized, Espar trained dealers or installers to remove and re-install warranted parts is included. Charges for labour performed by any other person are not included.

This warranty does not cover damage or defects caused by service or installation performed by anyone other than an authorized, Espar trained dealer or installer, from the use of replacement parts which are not genuine Espar parts, from causes such as abuse, accident or neglect, or from normal wear on parts such as glow plugs, atomizer screens, fuel filters, gaskets, fuses, lamp bulbs, wire harnesses, intake and exhaust tubing, and ducting. This warranty extends only to the original owner and may not be transferred unless Espar otherwise agrees in writing. Also, the warranty is valid only on the original installation unless Espar otherwise agrees in writing.

Espar reserves the right to change part specifications not adversely affecting performance without notice and to substitute new parts.

To obtain service under this warranty, contact the nearest authorized Espar trained dealer. Depending upon the location of the heater and type of installation, it may be required to ship the heater to the dealer for warranty service. The cost of shipping is borne by the owner. The owner of the heater will also be required to present proof of purchase and the date of installation to the dealer. Completing the Espar Warranty Registration process on-line within thirty(30) days after installation will suffice as proof of purchase and the date of installation. Registering the Espar warranty is not a pre-condition to warranty coverage and performance and will not affect the owner's rights under this warranty, so long as the owner makes other reasonable proof of purchase and proof of the date of product installation. To obtain service, a Warranty Claim must be completed. The dealer will perform warranty service subject to the provisions of this warranty and complete the Warranty Claim.

Some states and provinces do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
